- **Nationality:** A candidate must be a Citizen of India.
- **Minimum Experience :** At least 15 yrs of Work Experience in Power Sector in relation to Corporate Financial Management & Accounts including Cost & Budgetary Control, Institutional Finance & Working Capital Management (with 5 yrs of experience in medium to large organizations at Senior Management levels).

Internal candidates, either in service or retired, applying for the post must have served as regular General Manager of Accounts Wing.

- **Restriction on applying for the post of Director :** The Whole time Director shall not be considered for another board level position in another company for two years after he joins a company with the following conditions as per Article 125A:-
