## MINIMUM QUALIFICATION:

- (a) Master's Degree with at least 55% of the marks or an equivalent grade in a point scale wherever grading system is followed.
- (b) At least 15 years of experience as Assistant Professor in the Academic Level 11 and above or with 8 years of service in the Academic Level 12 and above including as Associate Professor along with experience in educational administration or
- (c) Comparable experience in research establishment and/or other Institutions of higher education, or
- (d) 15 years of administrative experience, of which 8 years shall be as Deputy Registrar or an equivalent post.

- 1. The age of superannuation shall be 62 years.
- 2. The prescribed application form is available on Institute's website www.dei.ac.in.
- 3. The filled in application may be sent to mail id "director@dei.ac.in" at the latest by 15-SEP-2019.
- 4. The duly signed hard copy of the completed application form submitted through email must reach "Director, Dayalbagh Educational Institute (Deemed to be University), Dayalbagh, Agra-282005" in a closed sealed envelope superscribing "Application for the post of Registrar" on or before 20-SEP-2019 along with all necessary documents self-attested and No Objection Certificate (NOC), wherever applicable.
- 5. Those in employment must apply through proper channel or submit "No Objection Certificate" from the concerned employers. However, an advance copy may be sent so as to reach by the last date.
- 6. The Institute will not be responsible for any postal delay in delivering the hard copy of the application of any candidate in the Institute.
- 7. Application incomplete or received after the last date of submission shall not be considered.
- 8. The Institute shall verify the antecedents or documents submitted by a candidate at any time of appointment or during the tenure of the service. In case, it is detected that the documents submitted by the candidate are fake or the candidate has undesirable clandestine antecedents and has suppressed the said information, then his/her service shall be terminated.
- 9. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the Institute reserves the right to modify/withdraw/cancel any communication made to the candidate.
- 10. The Institute reserves the right to alter/modify any condition at any stage.
