**1. Junior Scientific Officer (JSO):-** "Unreserved" on Direct Recruitment **or** on Deputation basis in the Pay Level-6 (35400-112400), 7<sup>th</sup> CPC plus allowances as per Central Government Rules.

#### **Essential Qualifications:**

(i) A degree in Science from recognized university or equivalent

#### OR

(ii) Diploma in Engineering and two years' experience in equivalent field and activity related to the post.

**Desirable:** Good working knowledge of handling modern office equipment.

#### **Experience:**

3 years of working in a publishing environment related to editorial / production / design & graphics.

#### Preferable domain of experience and commensurate with job expectation:

- i) Experience of publishing in STM (Scientific Technical Medical) domain especially editorial / production design & graphics.
- ii) Proficient in MS-Office and / or desktop publishing software
- iii) Working knowledge of any of the following markup languages: HTML / XML / SGML

#### Job Description:

Person would be responsible for assistance, maintenance and coordination of publishing activities of Vigyan Prasar.

#### Age Limit:

Not exceeding 30 years on the date of publication of advertisement (Relaxable for Govt. Servant and Employees of Autonomous Institutions / Recognized Universities / PSUs upto 5 years in accordance with the instructions / orders issued by Central Govt.

### Eligibility criteria for deputation:

Holding analogous post or those with three years in the next lower scale of pay in Govt. Deptt., Autonomous Bodies who fulfilled all the qualification and experience prescribed for Direct Recruitment.

- Candidates working in the Central/State Governments, / Universities / Recognized Research Institutions / Semi Govts. Or statutory or autonomous organizations (a) holding analogous posts with two years experience. (b) possessing the educational qualification laid down for direct recruits.
- 2. The period of deputation/contract shall not ordinarily exceed three years).

#### Other conditions:

- a) Persons employed in Government / Semi-Government / PSUs / Autonomous Bodies must submit their applications thorough proper channel. However, an advance copy of the application may be sent directly so as to reach us on time. (However, if called for interview, the candidates would have to produce a no objection certificate from the employer).
- b) Qualification, experience and age is relaxable by the Selection Committee for candidates otherwise found suitable for the job advertised.
- c) Applications in the prescribed format should reach the **Registrar**, **Vigyan Prasar**, **A-50**, **Institutional Area**, **Sector-62**, **Noida 201 309**, **within a period of one month** from the date of publication of this advertisement. The last date in respect of applications received only (by post) from candidates residing in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Jammu & Kashmir, Lahaul and Spiti District and Pangi Sub Divistion to Chamaba District of Himachal Pradesh, Andaman and Nicobar Islands or Lakshadweep or abroad, would be **45 days from the date of publication of advertisement**. The qualification and experience claimed must be backed by authenticated documentary proof. Each application should be signed by the candidate with the date. The envelope containing the application must be superscribed in bold letter as "**Application for the post of Junior Scientific Officer"**.
