No Institute Scholarship shall be admissible during/after the completion of the Project. The candidate will be considered as a Part Time Research Scholar after the completion of the project. Institute norms shall apply.
11. The Project Assistant can join the M.Tech by research provided (i) the PI has issued NOC and (ii) Candidate fulfills all the requirements for the admission to M.Tech by Research offered by the Institute, as mentioned in the ordinance No. 5 (at the link <https://aaa.iita.ac.in/?pg=ordinance>)
