5. Relaxation of One-year Teaching/Research experience for SC/ST candidates in Faculty selection will be given as per Rules/Guidelines issued by DoPT on time to time.

The link for submission of online applications in respect of above said posts along-with other relevant information will be activated on the date of advertisement on Employment News/ Rojgar Samachar. **The last date of online submission of applications will be Thirtieth Day (30<sup>th</sup> Day) from the date of publication of advertisement in Employment News/ Rojgar Samachar.**
3. The applicants applying in response to this advertisement should check their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing date of applications failing which their application will be rejected.
4. The Candidate must ensure that their photo and signature should be clearly visible in preview at the time of filling of application in online mode. If photo/signature image is displayed small or not visible in preview on website, that means photo/signature is not as per the AIIMS, Gorakhpur prescribed and, in that case, your application will be rejected. - Upper age limit shall be determined as on last date of submission of online applications.
- No age relaxation would be available to SC/ST/OBC/EWS candidates applying for unreserved vacancies.
- Age relaxation permissible to various categories is as under: -

Age relaxation to other categories will also be applicable as per the DoPT instructions. However, age relaxation will be regulated as per the DoPT instructions.

- Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/PwBD (OPH-OL)/EWS will be considered subjected to Caste/OH Certificate issued by the appropriate/Competent Authority on the prescribed format. Community should be clearly and legibly mentioned in the Certificate.
- Applicants applying for the posts reserved for OBC must obtain certificate of OBC (non- creamy layer) in the prescribed form issued by Competent Authority. The certificate should be of the current financial year, in accordance with instructions issued by the Government of India in this respect from time to time. Applicants should ascertain that they belong to the reserved categories (caste) enlisted in the Central List for the Other Backward Classes. OBC candidate(s) should not belongs to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s). 17. **Short Listing/Methods of the Selection:** The prescribed qualification is minimum and mere possessing the same does not entitle any candidate to be called for interview or for selection. Based on details of the candidate, the Screening Committee may short- list candidates for interview. If required there may be Screening test to shortlist candidates for interview in case large number of candidates apply for a post or posts.
