Minimum eligibility and qualifications for each position shall be in accordance with the UGC Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, Regulations 2018 (here in after referred to as UGC Regulations, 2018) published in the Gazette of India (No. 271, dated 18 July 2018)/UP Govt GO. No. 800/sattar-1-2019-18(114)/2010, dated 28 June 2019/GO NO. 1190/sattar-1-2019-16(114)/2010, dated 15 October 2019. General Norms & Terms and Conditions for the Appointment On the Post of Assistant Professor Teaching Posts under different Faculties/ Institutes to be filled on Contract basis that are Governed by the Concerned Regulations of UGC/AICTE, U.P. State Universities Act 1973 and Similar Statutory Bodies and Amendments therein. In the process of appointment, wherever applicable, the provisions stipulated in the Governor's Secretariat, U.P. order संख्या ई-3019/32-जी॰एस॰/2020 दिनांक-

18 मई 2021, संख्या-ई-4229/जी॰एस॰, दिनांक-02 जुलाई, 2021 and पत्रांक- ई-5862 / जी॰एस॰ dated 03 September, 2021 shall also be followed.

- Candidates must ensure before applying that they are eligible according to the criteria stipulated in the advertisement. If a candidate is found ineligible at any stage of recruitment process, he/she will be disqualified and their candidature will be cancelled.
- Applicants should possess the prescribed qualification, experience and eligibility criteria as on the closing date of application, as prescribed by the university from time to time for the respective posts.

3. Application Fee:

A non refundable application fee of Rs. 1500.00 (Rupees one thousand five hundred only) for Unreserved/ OBC/EWS candidates and Rs.1250.00 (Rupees one thousand two hundred fifty only) for SC/ST candidates.

- 4. Applicants must ensure to attach/submit appropriate documents regarding experience clearly stating their experience of past services. In this reference appointment letter along with their experience letter issued by the competent authority and dually attested should be submitted.
- 5. All supporting documents must be uploaded online on the Samarth Portal of the university. Scrutiny shall be done purely on the basis of the claims and their corresponding supporting documents uploaded on the portal of the university while filling up the form. The filled in application form should be produced during the time of the interview. Candidates have to bring along all the original documents during the interview.
- The complete online-application form duly signed by the candidate along with attested copies
 of testimonials must reach through Registered/Speed Post on or before 19.12.2025 to The

- 7. Degrees must be obtained from recognized institutions approved by UGC/AICTE or any other relevant statutory body. Degrees from foreign universities must be supported by an equivalence certificate issued by the Association of Indian Universities (AIU), New Delhi. Provided that candidates who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009, or the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2016, and their subsequent amendments from time to time, as the case may be, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for Recruitment and Appointment of Temporary Assistant Professor or any Equivalent Position in any Faculty, College or Institution of the University.
- 8. Provided further that the award of degree to candidates registered for the M.Phil./Ph.D. Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Byelaws/Regulations of the Institutions awarding the degree. All such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for Recruitment and Appointment.
- (a) NET/SLET/SET shall NOT be required for such Master's Degree Programs in disciplines for which NET/SLET/SET accredited Test is not conducted.
 - (b) A relaxation of 5% marks may be provided from 55 to 50% marks to the Ph.D. degree holder who have obtained their degree prior to 19th September,1991 for all those positions governed by the UGC, Regulations.
- 10. The candidates employed in Government Sectors/Autonomous Bodies must produce the "No Objection Certificates" from their organization/employer at the time of interview with an unambiguous certificate that no vigilance case is pending/being contemplated against him/her.
- Candidates desirous of applying for more than one post/category should submit separate applications for each post/category along with requisite application fees.

- Applications received without the requisite documents, fee or after the prescribed date will not be entertained in any case.
- 13. Incomplete applications shall be summarily rejected.
- 14. There shall be a written test for Assistant Professor post. A test of teaching skill shall be conducted from the shortlisted candidates through power point presentation at the time of interview. The research score will be published on university website. The candidate has to submit the objection in the research score (API) if any, within seven days (07) from the date of publication on university website (संख्या-ई-4229/जी॰एस॰, दिनांक- 02 जुलाई, 2021 एवं संख्या ई-3019/32-जी॰एस॰/2020 दिनांक 18 मई 2021) राज्यपाल सचिवालय उत्तर प्रदेश, लखनऊ-226027 तथा पत्रांक-ई-5862 / जी॰एस॰ दिनांक 03 सितम्बर, 2021).
- 15. Mere fulfilling of minimum eligibility will not entitle any candidate to be called for Interview.
- 16. Only matriculation/SSC Certificates issued by the concerned educational board will be considered as proof of date of birth.
- 17. Candidates belonging to OBC/SC/ST/EWS category should submit relevant valid certificates as per prescribed format of the state of Uttar Pradesh. The benefit of reservation will be applicable to the resident of Uttar Pradesh Only. The candidates must attach the domicile certificate if would like to avail the benefit of reservation. At any stage, if it is found that the certificate is not valid, the candidature shall stand cancelled and appointment made, shall be terminated with immediate effect along with recovery. Candidate belonging to OBC in creamy layer will not be entitled to the benefit of reservation and shall have to apply as Unreserved Category (UR) candidate.
- 18. Reservation Policy will be followed as per Government of U.P. Rules.

- 20. The candidate must enclose the income tax return statement (Form 16) and salary slip of last three years if already employed in public/private sector.
