The Institute reserves the right to restrict the number of shortlisted candidates for further recruitment process to a reasonable number on the basis of higher qualifications and/or experience.
- 3. The date for Interview will be communicated later to the shortlisted candidates **through email ONLY**. The candidates are advised to check their emails regularly.

The shortlisted candidates will be required to bring all original Certificates, Degrees and other documents pertaining to their educational qualification, professional qualification, work experience, age etc. for verification purpose at the time of final selection process along with one set of photocopies of these documents.

- 5. Crucial date for determining the age limit shall be the closing date for the receipt of applications.
- 6. **Selection Process** Through Interview, which may also be conducted through online mode. Candidates are required to mandatorily mention their <u>email ID</u> in the application form.
